# Development of legislation and institutions

The completion of the process of transferring responsibilities for health to the autonomous communities in 2001 also meant the completion of the new configuration and structure of the National Health System, as it incorporated the health services of those communities which still remained under the control of Social Security (Insalud).

From the state legislation which created the NHS, with Act 14/1986 of the 25<sup>th</sup> of April, the General Health Act, and with the closure of the period of health transfers with Act 16/2003 of Cohesion and Quality in the National Health Service, together with other more specific basic regulations (related with the rights and guarantees of patients and health personnel), the autonomous communities have developed the legal framework of the NHS by means of the corresponding legislation of development (autonomic health laws).

The period 2004-2007 has seen the development of this legislation with which all the administrations have endeavoured to maintain, reinforce and develop the NHS, guaranteeing compliance with its fundamental principles (universal public coverage, provision of complete health services, equity and quality in the services provided, coordination and cooperation of the administrations involved and collaboration with the private sector), ensuring its stability while maintaining and improving the care provided and health protection for society in general.

This process begins with the development of the fundamental general aspects by the autonomous communities, continues with the progressive maturity of the institutions as reflected in the increasingly technical issues dealt with in configuring the services and rights and guarantees of the public, creating more elaborate organizational solutions. The objective of these is to better perform the diverse operations required for the protection and improvement of the health of the general public or in handling specific health issues.

In 2004-2007, all the administrations have worked to maintain, strengthen and develop the cohesion and quality within the NHS starting with the changeover from the previous period (completion of the transfer process and the new finance system), which has led to a legislative development which has been progressively more precise and complex.

## The rights and guarantees of the citizens

The rights of citizens in the National Health System (NHS) are specified in several categories which are separate, although they are interrelated.

The most basic primary right is the *right to the protection of health and health care* as recognised in Article 43 of the Spanish Constitution. This is specified in the list of health services in the Catalogue of Services of the NHS established in *Article 7 of the Law of Cohesion and Quality* and is ensured at the fundamental level nationwide by the service charter of the NHS, and specifically in each area through the service charter of the autonomous communities (table 33).

The period from 2004 to 2007 has seen the development of this new configuration of the legislative framework for the health services with the approval of the Royal Decree 1,030/2006 of the 15<sup>th</sup> of September, which establishes the charter of common services of the NHS and lays out the procedure for bringing these services into line across the whole country. Meanwhile, the autonomies have been progressively establishing specific regulations for their territories, approving and modifying them to define their final form, including some of the autonomies which have received

this transfer most recently (Extremadura, Aragon, Galicia and the Balearic Islands).

There has been a trend whereby the contents of the health services not included among the original charter of common services of the NHS have become generally available among the autonomies by a process of assimilation, where they have spread from one community to the others. This is the case of the Cantabrian Programme of Dental Health for Children, from 1989, which includes orthodontics, according to protocol, and dental care for disabled persons. There is also the Children's Dental Care Programme of Navarre, from 1991, which included dental care for children from 6 to 15 years of age (in 2003 this was raised to 18 and introduced gradually until 2006, by which time it covered 70-75 % of the target population). Andalusia also provided dental care for minors prior to the period under analysis. Extremadura included this type of dental service in 2005.

Some autonomous communities complement the services in their charter of services with support for specific expenses derived from illness: expenses for relatives of Alzheimer's sufferers (Andalusia, 2004), travel expenses for health care (Cantabria 2007), support for persons with haemophilia or coagulopathies affected by HCV (hepatitis C virus) after treatment by the health services (Basque Country and Galicia)

As regards the configuration of the content of the additional services provided by the autonomies, it can be noted that during the first 2 years there was an intense activity of including new services and updating the existing ones. From 2006 onwards, the tendency has been towards limiting the entry of new services, and admitting selectively only those services which address specific health problems. For example, Catalonia included services in its charter such as diagnosis prior to implants, treatment of senile macular degeneration, a programme of medical attention for gender identity disorder (also in Andalusia), HIV related facial hypertrophy, an online haemofiltration technique, chiropody for diabetes sufferers and coverage for certain mental health programmes.

Other complementary rights were included alongside the right to health services, as recognised in Article 4 of the *Cohesion and Quality Act*, such as the *right to a second medical opinion, and treatment within a specific time* (waiting lists). These in turn were joined by the rights recognised in Law 41/2002 regulating patient autonomy and the rights and obligations regarding information and clinical documentation (right to medical information, to privacy, patient autonomy –informed consent, advanced directives, right to information on the NHS and a choice of doctor–).

The autonomous communities have carried out their own development of the rights of users at the regional level taking the basic contents as their starting point, although at different speeds and with differing reaches. As regards the right to a second opinion, while it is included in many of the communities' regulations, the decrees developing it have been approved in the period since Andalusia first introduced it in 2004, until it has extended to nearly all the communities, with the Valencian Community, Murcia, Catalonia, Galicia, Castile and Leon, Navarre and the Basque Country passing specific legislation in 2007.

The guarantee of maximum response times has been established gradually, then developed and modified during the period prior to 2007, when practically all of the communities had the required administrative and information tools (principally waiting lists) to be able to offer the service required within the period established. The reach and the solutions offered by each community differ, although they all work towards reducing this waiting time (in 2007, Andalusia was able to reduce the maximum waiting period for surgery from 180 days to 120).

As regards the rights recognised under the law of patient autonomy, various aspects related with *informed consent* have been legislated at community level, as well as advanced directives, as laid out in Article 11. General legislation regulating advanced directives have been approved (Navarre, Castile-La Mancha, Balearic Islands, Madrid) while the operation of registries of advanced directives have been developed (2004 in Andalusia, 2007 in Valencian Community, Murcia, La Rioja, Cantabria, Canary Islands, Madrid, Castile-La Mancha, Extremadura, Castile and Leon and Navarre). The others were created prior to the period under analysis (for example, Catalonia in 2002).

Besides this, the right to *patient privacy* in the automatic handling of personal data has been guaranteed in all communities and that of personal privacy by all the autonomic health authorities. It is clear that there has been constant, abundant and widespread activity on the part of the autonomous communities to ensure compliance with the law on data protection, with special emphasis on data relative to the health services.

In relation with the right to *free choice of a recognised general practitioner* for the entirety of the National Health System in article 5.1 d) of the Act 44/2003, of the 21<sup>st</sup> of November, on the organisation of medical professions, autonomous services which had not yet passed legislation developed this content in 2006, specifically the case of the Valencian Community and Extremadura, but from 2007 there has been a tendency towards the express recognition of this right to choose, not just in primary care, but also in specialised care (Aragon).

These rights mentioned above have now been recognised at national level and will be extended to Spanish citizens abroad, as specified in Law 40/2006, and developed in some autonomous communities (La Rioja).

To these *common rights* the autonomous communities have added other *specific rights* related with certain areas of healthcare, whether through a general or specific set of regulations (in 2007 Cantabria recognised rights through birth in its health area, which already existed in other communities, and Andalusia passed legislation on the rights of persons subjected to genetic analysis).

Besides the common rights recognised at regional level, there has been legislation on the guarantees offered, such as the guarantee plan for the rights of persons in relation with their health in Castile and Leon.

## Health service organization

The organizational structure of the National Health System has undergone profound modifications as a result of the readjustments caused by the transfer of functions and services to the health departments of the autonomous communities.

Following the creation and adaptation of the required structures, the period 2004-2007 has seen the development of health organizations in the autonomous communities characterised by stability, and a steady growth and increase in complexity derived from the many solutions adopted in the design of their administrative bodies as well as the approaches adopted in managing healthcare (table 34).

In the organization of health services we see first a similar situation in each autonomous community of a health department for carrying out the health policies. Although they exist in all autonomous communities, those which have most recently received the transfer of responsibilities display a number of adjustments to adapt to these new functions and services.

These departments have all developed a similar structure, although some assume other responsibilities, such as that of Consumers' Affairs (Asturies, Balearic Islands, Castile and Leon and La Rioja), Social Services (Cantabria, Galicia, Madrid, Murcia, La Rioja and Extremadura) and Work (Aragon). It is normal for the structures to change after autonomic elections in order to adapt to the stance on health policy adopted by the new government, so many have been restructured following the elections of 2007.

The different *autonomic health services*, which are responsible for managing the public health services, depend on these health departments. Once created in each autonomy with the transfer of functions and services from Insalud, the period 2004 to 2007 has seen them adopt different structural modifications. On one hand, there have been general modifications through the approval of new statutes (Balearic Islands and Navarre in 2006) or the development and modification of their organization (Castile and Leon, Valencian Community and Navarre in 2007).

On the other hand, the territorial organization of the health services of several autonomies have been restructured by means of a general or specific alteration of their *health maps* (Aragon, Asturies, Castile-La Mancha and Catalonia), or specific measures aimed at the organizations of primary care (Aragon, Galicia and Andalusia<sup>17</sup>), or mental health (Extremadura, Navarre and the Basque Country).

During this period there have also been a great number of specific interventions in the organization of hospitals and specialist centres.

The increased responsibility of the autonomous communities in health issues and the stimulus for the NHS at the start of this period has led to an intense use of these new responsibilities by the communities, which has in turn caused an increase in the organizational structure under the criteria of specialities, capacity and participation.

The *creation of new organs and organisms* designed to carry out specific functions or activities related with healthcare, to respond to a particular health problem or specific sectors of the population has been a frequent occurrence: transfusion centres and services, haemotherapy and haemovigilance networks, autonomic transplant services in the Balearic and Canary Islands, Committees of Bioethics, as in the Basque Country, the Canary Islands, and Catalonia, or the Genetics Council of Andalusia. Foundations for Biomedicine Research have been created in Madrid and the Research Advisory Board in Murcia.

The creation of these organizations has also been aided by the state (with the creation of the National Bank of Cell Lines and the Research Centre for Regenerative Medicine) and reached its highest point in 2006 with the setting up of numerous executive, consultative and participative organs of many different kinds (Catalonia in 2006 and Castile-La Mancha in 2007).

The development of organizations of the National Health System in the autonomous communities has been characterised by stability and a steady growth and increase in complexity derived from the many solutions adopted in the design of their administrative bodies as well as the approaches adopted in managing healthcare.

Within this evolution of the organization of the health system, there has been a growing involvement of *local administrations* as in the case of Catalonia, where 2006 saw the development of territorial health authorities to ensure collaboration between the local authorities and the health department of the community.

The *pharmaceutical organization* has also undergone diverse modifications at community level during this period as a consequence of the approval of Law 29/2006, of the 26<sup>th</sup> of July, of Guarantees and Rational Use of Medicines, and the modification of the revised text of the law governing limited companies through Law 7/2006. New pharmacy laws have been passed in autonomous communities to replace the existing ones, including the reorganization of pharmaceutical care (in the case of the Canary Islands, Castile-La Mancha in 2005, Extremadura in 2006 and Andalusia, Asturies y La Rioja en 2007)and specific laws governing veterinary medicines (Valencian Community 2007).

The analysis of health organizations must also consider the *forms of management*. The period 2004-2007 has seen the development of diverse strategies in the approach to managing healthcare services. Galicia, for example, has proposed eliminating the public health foundations which run its hospitals in order to integrate them into the NHS. Madrid, on the other hand, opted for the creation of a public company to manage the radiodiagnostics service and six public companies to run and administer as many new hospitals.

In any case, the intensive use of indirect forms of management in more and more areas of health management through agreements and contracts has led to a need to rationalise this procedure. Aragon passed a motion specifically to regulate the agreements reached in matters pertaining to health services and Catalonia has approved the creation of a list of agreements and contracts.

In discussing the instrumental role of management, it is also necessary to consider the advances that have been made in the incorporation of *information and communication technologies*. Royal Decree 1,084/2004 has led to the introduction of the individual health card (Catalonia in 2001 and Canary Islands in 2007), electronic prescriptions (Andalusia and Catalonia in 2007) and other procedures carried out electronically (invoicing in Andalusia).

Finally, the organizational dimension also includes issues related with *human resources*. It should be borne in mind that health personnel were transferred to the different autonomous health authorities prior to the 2004-2007 period, once the responsibilities for health services had been passed to the autonomous communities (with the exception of Ingesa). This was followed by the passing of state legislation which formed the basis from which the autonomous communities developed their organization of health personnel and which served as reference for their regulations: Act 44/2003, of the 21<sup>st</sup> of November, on the Organisation of Medical Professions and Act 55/2003 of the Statutory Framework of Statutory Personnel as well as their regulations for development.

The autonomous communities began an active personnel policy within this framework with the creation of instruments for their own *personnel organization*, coordinated by the National Commission on Human Resources, in which these communities participate.

The early phase of the 2004-2007 period saw numerous general measures adopted in the development of the statute of health personnel at the community level (although some have adapted only recently, such as Castile and Leon in 2007), followed by a gradual transition towards specific areas, such as the integration and restructuring of health personnel (Balearic Islands in 2006, Asturies, Castile-La Mancha, Extremadura, Galicia, La Rioja, Madrid and Murcia in 2007), the configuration of professional careers (Andalusia<sup>18</sup>, Canary Islands, Castile-La Mancha and Valencian Community in 2007), and several measures aimed at stabilising, specialization, training and motivation of health personnel which will be analysed in the corresponding section of this report.

### Prevention, control and monitoring of illnesses and promotion of health

Different measures affecting organization were approved throughout the period between 2004 and 2007 for the prevention, control and monitoring of illnesses. These responses to specific illnesses or health issues were mostly derived from actions prepared at national level and then developed by the communities, although these also adopted their own measures which illustrate the particular problems they face and the priorities their policies address (tabla 35).

This can be seen in the handling of the flu virus, which was the object of several measures during this period in all the communities, stemming from the actions carried out by the state government (specifically, the creation of the National Executive Committee for the Prevention, Control and Monitoring of the Epidemiological Evolution of the Flu Virus and by updating the National Plan for Preparation and Response to a Flu Pandemic).

The autonomous communities also developed specific instruments for epidemiological vigilance within the National Epidemiological Vigilance Network (Castile and Leon reviewed its Vigilance Network in 2007 and updated the system of illnesses of obligatory disclosure).

The autonomous communities have intervened through the adoption of specific measures in other areas, such as: cancer (Andalusia, Catalonia, Valencian Community and Extremadura with an Advisory Board in 2007), mental health (with the creation in Aragon, Balearic Islands, Catalonia and the Basque Country of figures responsible for improving the treatment of this area), drug addiction (Asturies, Madrid, Aragon, Extremadura, Galicia, Balearic Islands, Murcia and the Basque Country), HIV/AIDS (Basque Country, Galicia and Madrid), asthma (Madrid), developmental disorders (Andalusia) and palliative care (Madrid and Navarre).

The specific action of the central and autonomous governments on health issues has not been limited to determined illnesses, but also includes the prevention of illnesses and nutrition and eating disorders.

This can also be seen in the measures adopted to counter tobacco addiction. Law 34/2004 has been followed up by the passing of specific legislation in the autonomous communities to develop regulations on the sale, consumption and advertising of tobacco (Asturies in 2005 and Andalusia in 2007<sup>19</sup>).

In relation with problems of nutrition and eating disorders, such as anorexia and bulimia, Madrid created the Institute of Nutrition and Eating Disorders, and Navarre created a working group.

The measures adopted at regional level have also focused on the promotion of health through the development of greater activity (especially in Catalonia in 2006 and Aragon and Asturies in 2007) in subsidising projects aimed at promoting health in general and healthy lifestyles (more physical activity and balanced diet), health education, information and participation in health.

#### Organization of health-related activities

The period from 2004 to 2007 has been notable for the increase in the development of measures adopted by autonomous communities on private activities with an impact on public health. This shows that the autonomous

Taking their cue from state legislation on the administrative authorisation of the installation, operation and modification of health centres and services (Royal Decree 1,277/2003), the autonomous communities have passed their own legislation regarding the authorisation of health centres and services (Asturies in 2006 and Aragon in 2007), surgical centres (Castile-La Mancha in 2007), *Clinical Laboratories* (Extremadura in 2007) and the regulation of laboratories of clinical analysis (Castile and Leon in 2007).

Intervention by the autonomous communities has intensified in those establishments which, despite not being health centres in a strict sense, carry out activities which are directly related, such as *audio prosthesis* centres (Basque Country and Extremadura) and optical establishments (Asturies). Regulations have also been applied to informal private activity such as the use of automatic external defibrillators by non-medical personnel (The Basque Country, Aragon, Valencian Community and Madrid in 2007, and Castile and Leon prior to this period) and the accreditation of centres providing acute hospital treatment (Catalonia in 2006).

This kind of public health measure has been extended to other private activities which have a bearing on health. While it may be considered that it belongs more to the sphere of consumer affairs, the fact that these interventions have health-related objectives, and the context in which they are placed makes it clear that they are public health issues, as in the situation of tanning centres (Aragon and Madrid in 2007), tattoos and other forms of body art (Catalonia in 2005 and Cantabria in 2007), hydrology centres (Castile-

La Mancha in 2007), natural therapies (Catalonia in 2007), installations with risk of Legionellosis (Andalusia) and biocide establishments and services (Andalusia and La Rioja in 2007).

The period from 2004 to 2007 has seen an increase in the development of measures adopted by autonomous communities over private activities related with public health issues.
