CHAPTER VI. On Quality

SECTION 2.a The Observatory of the National Health System

Article 63. Observatory of the National Health System

The Observatory of the National Health System will be created, as an independent organ of the Ministry of Health and Consumers' Affairs, to provide a permanent analysis of the National Health System as a whole, by comparing studies of the health services of the autonomous communities in the areas of organization, provision of services, health management and results [...].

[...] The Observatory will prepare an annual report on the state of the National Health System, which will be presented by the Ministry of Health and Consumers' Affairs to the Interterritorial Council of the National Health System.
